1) 6:00 p.m. Call to Order – The meeting was called to order at 6:12 p.m.

After adjournment, President Sorenson announced that the Board concluded the performance evaluation of the General Manager and voted unanimously to award him a 2.9 percent Cost of Living Adjustment, bringing his new annual salary to \$195,840.

- 9) <u>Presentation</u> Trish Chapman and Hilary Walecka of the State Coastal Conservancy gave a presentation on the status of the former San Clemente Dam after removal and discussed potential future public access to the site.
- 10) <u>Public Comments</u> Nikki Nedeff, Joyce Stevens and Rita Dalessio of the Monterey Pine Forest Watch thanked the Board for the recent grant from the community grant program and presented them with copies of their newly published book, which the grant helped fund.

Bruce Dormody reported that there have been recent arrests for illegal marijuana growing in the Big Sur area that the offenders have been entering through the Mill Creek Redwood Preserve. He encouraged increased patrol of the park.

Donna Dormody reiterated the comments about illegal growers, saying they have seen additional trespassers near their property since the arrests.
