## Program Guidelines

### Criteria for Content

LGO! programs meet at least one or more of the following criteria: support the MPRPD mission, are oriented toward conservation, sustainability, or ecology, explore the richness and diversity of the Monterey Peninsula's natural and cultural history, are educational, inquiry-based, thematic in approach, and demonstrate professionalism.

### Logistics

- Participation in LGO! Programs is FREE.
- MPRPD staff and instructors have access to rosters and participant contact information.
- MPRPD staff manage insurance, facility reservation, participant registration, public inquiries, and volunteer assistance for the day of the program.
- Instructors are responsible for sign-in, programmatic content, supplies, and professionalism.

Completed proposals will be reviewed carefully. Selected instructors will be contacted for an interview.

All instructors will work under contract, which will specify the services being provided including date, time, participant age range, and location. Instructors will be required to complete a Live Scan (fingerprint) background check.

All programs are free to participants and will be advertised in the MPRPD's *Let's Go Outdoors!* (LGO!) Adventure Activities Guide.

In accordance with federal law, MPRPD will hire or contract only individuals who are legally authorized to work in the United States. As a condition of employment, you will be required to present proof of identity and employment eligibility.
