#### DISCUSSION:

The District contracts annually, as required, to have the financial statements audited by a professional independent certified public accounting firm qualified to audit governmental entities. The California Code of Regulations (CCR) sets forth the Minimum Audit Requirements in Title 2, Section 1131.2.

The attached, Report of Certified Public Accountants and Financial Statements for Fiscal Year Ended June 30, 2019, was presented at the December 11, 2019 Board meeting by Robert Perl of the firm White Nelson Diehl Evans LLP, Certified Public Accountants and Consultants (**ATTACHMENT 1**). An opportunity was provided by the Partner for members of the Board to ask questions or request clarification. Upon final approval, bound final copies of the report and letters will be distributed.
